<u>SEBI Circulars on Common and Simplified Norms for Processing Investor's Service Request by RTAs and Norms for furnishing PAN, KYC details and Nomination.</u>

Attention of the Holders of Securities in Physical Mode is invited to SEBI Circular No. SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023 read with SEBI Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2023/158 dated September 26, 2023 & SEBI Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2023/158 dated November 17, 2023 *inter alia* mandating the furnishing of PAN, Address with PIN code, Nomination, Contact details, Bank Account details and Specimen Signature by holders of physical securities for their Folio Nos. on or before December 31, 2023.

#### Important notes to the holder of physical shareholders:

- 1. The shareholders of the physical securities who have not updated their PAN, Address with PIN code, Nomination, contact details, Bank Account details and Specimen Signature in the manner provided in the SEBI Circular on Common and Simplified Norms for Processing Investor's Service Request by RTAs and Norms for furnishing PAN, KYC details and Nomination will not be able to lodge any grievance or avail any service request from the RTA.
