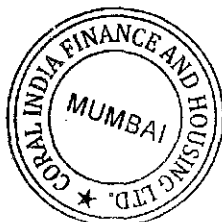
However, Equity shares of Coral India Finance and Housing Limited continue to be listed with BSE Limited (BSE) and National Stock Exchange Limited (NSE).
