4. Remote E-voting by electronic mode shall not be allowed beyond 5.00 p.m. IST on 13th September, 2015.
5. Cut-off date: Monday, 7th September, 2015.
6. Members who have acquired shares of Company after 7th August, 2015 (which is the date considered as the cut off date for dispatch of the Notice to Shareholders) and up-to the Cut-off date mentioned above, may obtain their login details for remote e-voting by writing to the Company on cs@coralhousing.in or to the Share Transfer Agent at the address and contact details mentioned below.
